#### 1. Definitions

- (a) "Contract" means the agreement entered into between the Client and the Service Provider, together with the Contract Documents referred to therein, including all attachments, appendixes, and all documents incorporated by reference therein.
- (b) "Contract Documents" means the documents listed in the Contract, including any amendments thereto.
- (c) "Contract Price" means the price payable to the Service Provider as specified in the Contract, subject to such additions and adjustments thereto pursuant to the Contract.
- (d) "Completion" means the fulfilment of the committed services by the Service Provider in accordance with the terms and conditions set forth in the Contract.
- (e) "Client" means the entity purchasing the Services.
- (f) "Services" means the services the Service Provider will perform as specified in the Scope of Services in Appendix A.
- (g) "Service Provider" means the natural person, private or government entity, or a combination of the above, whose bid to perform the Contract has been accepted by the Client and is named as such in the Contract.
- (h) "ADB" is the Asian Development Bank.

#### 2. Applicable Law

The Contract shall be interpreted in accordance with the laws of the Client's country.

#### 3. Language

All communications and documents related to the Contract shall be in English.

#### 4. Assignment

Any assignment of this Contract or of any rights hereunder, in whole or in part without the prior written consent of the Client shall be void.

#### 5. Fraud and Corruption

This Contract shall be covered by the provisions of <u>ADB's Anticorruption Policy</u>(1998, as amended to date) and <u>Integrity Principles and Guidelines</u> (2015, as amended from time to time) that requires Borrowers (including beneficiaries of ADB-financed activity), as well as Service Providers and Contractors under ADB-financed contracts, to observe the highest standard of ethics during the procurement and execution of such contracts.

#### 6. Performance of the Services

The Service Provider shall carry out the Services with due diligence and efficiency and shall furnish to the Client such information related to the Services as the Client may from time-to-time reasonably request. The Service Provider shall at all times cooperate and coordinate with the Client with respect to the performance of the Services.

The Service Provider confirms compliance with above standards and parameters.

#### 8. Service Completion Schedule

The Services should be completed as per schedule indicated in the **Scope of Services** but not exceeding 4 (four) months from the date of signing of contract.

#### 9. Fixed Contract Price

The prices indicated in the Form of Quotation are firm and fixed and not subject to any adjustment during contract performance, subject to Clause 11 [Payment] below.

#### 10. Taxes and Duties

The Service Provider shall be entirely responsible for all taxes, duties, license fees, etc., incurred until completion of the Services.

#### 11. Payment

Upon submission by the Service Provider of claim and subsequent verification of the claim by the Client, payment of the contract price shall be made in the following manner:

- (a) Advance payment of 10% within 14 days of signing the contract, upon evidence of mobilization of the Service Provider upon submission of the Bank Guarantee of equal amount.
- (b) 10% on submission of the Inception Report accepted by the Client.
- (c) 25% on submission of the draft final report accepted by the Client.
- (d) 30 % upon submission of the final report accepted by the Client.
- (e) 25% upon finalisation of Economic Benefit analysis documents by the ADB.

#### 12. Resolution of Disputes

The Client and the Service Provider shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute between them under or in connection with the Contract. In the case of an unresolved dispute, the dispute shall be settled in accordance with the provisions of the Arbitration and Reconciliation act 1991.

13. Independent Service Provider

Nothing contained in this Contract shall be construed as establishing or creating the relationship of master and servant, employer and employee or principal and agent between the Client and the Service Provider, or his employees or agents or other persons engaged by the Service Provider to perform any of the services.

14. Intellectual Property Rights

Intellectual Property Rights: (a) The Service Provider shall indemnify the Client from and against any and all claims, liabilities, obligations, losses, damages, penalties, actions, judgments, suits, proceedings, demands, costs, expenses and disbursements of whatsoever nature that may be imposed on, incurred by or asserted against, the Client during or in connection with the Services by reason of: (i) infringement or alleged infringement by the Service provider of any patent or other protected right, or (ii) plagiarism or alleged plagiarism by the Service provider.

15. Failure to Perform

The Client may terminate the Contract if the Service Provider fails to perform the services, in accordance with the above terms and conditions, in spite of a 14-day notice given by the Client, without incurring any liability to the Service Provider. In the event of such termination, the amount due under the Contract shall be subject to equitable adjustment.

16. Termination Due to Integrity Violation

The Client may terminate this Contract, in whole or in part, if the Service Provider, in the judgment of the Client has engaged in integrity violations in accordance with Clause 5 [Fraud and Corruption], in competing for or in executing this Contract.

17. Other Grounds for Termination

The Client may also terminate this Contract, in whole or in part, if the Service Provider becomes insolvent, bankrupt or gives the Client reasonable evidence of its inability to complete the Services as specified, or fails to correct any non-conformity in the Services or performs in bad faith by willfully not observing the terms and conditions of this Contract.

18. Force Majeure

The Service Provider shall not be liable for penalties or termination for default if and to the extent that its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

- (a) For purposes of this Clause, "Force Majeure" means an events beyond the control of the Service Provider and not involving the Service Provider's fault or negligence and not foreseeable. Such events may include, but not restricted to, act of Client in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions, and freight embargoes.
- (b) If a Force Majeure situation arises, the Service Provider shall promptly notify the Client in writing of such condition and the cause thereof. Unless otherwise directed by the Client in writing, the Service Provider shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by Force Majeure event.



#### 19. Accounts and Records

- (a) The Service Provider shall keep accurate and systematic accounts and records in respect of the Services in such form and detail as are customary in its profession and are sufficient to establish accurately that the costs have been duly incurred.
- (b) Notwithstanding anything to the contrary stated herein, the Service Provider shall maintain accounts and records, including original receipts, invoices and other supporting documents evidencing payments made by the Service Provider under this Contract, for the period of the Services and for a period no less than 3 years after the expiration or termination of this Contract.
- (c) The Service Provider shall permit ADB to inspect the accounts, records, and other documents relating to the submission of bids and contract performance of the Service Provider and to have them audited by auditors appointed by ADB.

20. Suspension of ADB Loan or Credit.

In the event that ADB suspends the Loan or Credit to the Client, from which part of the payments to the Service Provider are being made, the Client is obligated to notify the Service Provider, with copy to the Client's representative, of such suspension within 7 days of having received ADB's suspension notice.

21. Termination Notice Due to Non-payment If the Service Provider has not received payments due within the 28 days as provided for in Clause 11[Payment], the Service Provider may immediately issue a 14-day termination notice.



#### Appendix-A

#### Scope of Services

#### A. Project Background

- Since the early years of the 21<sup>st</sup> century, the Government of India has given high priority to develop effective flood and river erosion management systems along major rivers. In Assam, the State Government of Assam (SGoA) is committed to manage floods and protect riverbanks from erosion in the Brahmaputra river valley with its strategic partner in this sector, the Asian Development Bank (ADB).
- The proposed Climate Resilient Brahmaputra Integrated Flood and Riverbank Erosion Risk Management Project in Assam (CRBIFRERMP) of a total cost estimated around \$250 million is in preparation. The project is planned to be financed through a ADB loan of about \$200 million and SGoA's counterpart funds. The project is anticipated to start to be implemented before the end of 2023.
- 3. CRBIFRERMP will build upon the experience from the recently completed ADB-financed Assam Integrated Flood and Riverbank Erosion Risk Management Investment Program (2010-2020) (AIFRERMIP).¹ It will focus on the Main Stem of the Brahmaputra River in Assam and follow a climate-resilient holistic, integrated, systematic, and reach-wise approach to flood and riverbank erosion risk management.
- 4. Incorporating structural and nonstructural measures in selected river reaches in Assam, the proposed project aims to (i) reduce economic vulnerability and social disruption induced by flood and riverbank erosion in four selected flood-prone subproject areas along the main stem; (ii) strengthen the institutional capacity for climate change-oriented flood and erosion management; (iii) develop further the knowledge base for informed decision-making on preventive measures and preparation of river stabilization guidelines and plans; (iv) stabilize selected river reaches by integrating climate-resilient riverbank erosion and flood protection works to ultimately enhance navigation and recover lost floodplain land ('land and/or charland reclamation'); and (v) enhance the livelihoods of the most vulnerable of the riverine population.
- 5. In particular, the project will build cost-effective long-guiding geotextile sand-filled bag riverbank revetments in a climate-resilient adaptive way to cope with the dynamic riverbank erosion, contributing to a more significant river stabilization enabling ultimately navigation. Also, climate-resilient modern flood embankments will be built and/or rehabilitated and will have openings (ie: sluice gates with fish passes) to enable river-floodplain interconnectivity and enhance biodiversity.
- 6. It is anticipated that CRBIFRERMP will have the following three broad outputs:
  - (i) Output 1. Climate resilient flood and riverbank erosion risk mitigation measures in four subproject areas implemented and maintained. The project will combine structural and nonstructural measures in four subproject areas to stabilize their respective river reaches by applying the integrated river stabilization approach initiated under AIFRERMIP Specifically, the structural measures will include about (i) 90 km of long-guiding riverbank protection with innovative technologies, (ii) 50 km of pro-siltation measures (porcupines), and (iii) 5 km of climate-resilient flood embankment, 2 including sluice gates and fish passes

The multitranche financing facility to India for the Assam Integrated Flood and Riverbank Erosion Risk Management Investment Program was approved by ADB in 2010 to increase the reliability and effectiveness of flood and riverbank erosion risk management systems in three priority flood-prone subproject areas in Assam, through structural and nonstructural interventions, policy strengthening, and institutional and knowledge bases. FREMAA was the executing agency of this investment program whose second and final project was physically completed in October 2020.

to facilitate drainage and maintain river-floodplain interconnectivity, thus enhancing biodiversity. Nature-based solutions will be pilot-tested, including possible involvement of private sector. As a lesson from previous investments, monitoring, adaptive maintenance, and emergency works for five years after construction will be included to cope with the

highly dynamic river system.

(ii) Output 2. Flood and riverbank erosion knowledge base strengthened. This output will enhance the various decision support tools initiated under AIFRERMIP. In particular: (i) the flood forecasting and warning system will be strengthened; (ii) flood mapping will quantify inundation extents, depths, and durations, enabling a determination of people and critical assets at risk of flooding; (iii) erosion prediction and embankment breach models will be enhanced; (iv) the asset management system will be improved to ensure operation and maintenance is financed and implemented according to a risk-based approach. Data will be systematically collected, including: (i) river surveys (bathymetry, gauging, and sediment measurements); (ii) topographic surveys to derive digital elevation models; and (iii) asset condition surveys.<sup>3</sup> Existing guidelines for design of flood and riverbank protections will be expanded to address climate impacts and resiliency, river stabilization principles, and successfully piloted nature-based solutions. This output will also include capacity building to enhance FRERM and disaster resilience of the state and riverine communities.

- (iii) Output 3. Vulnerable people's livelihoods supported. This output will address people living on the embankments or chars in the subproject areas who are poor and destitute and negatively affected by river erosion or floods. It will also specifically target women in these locations. Support will include: (i) training female headed households and female self-help groups on spinning, weaving, marketing the silk, establishing weaving centers with modern handlooms and sewing machines; (ii) increasing vegetable production by providing climate-resilient seeds, promoting improved agricultural practices, and extending marketing support; and (iii) providing vocational training for unemployed youth. Subsistence and small farmers will be supported with: (i) assistance in creating businesses around agriculture and fisheries; (ii) help in identifying opportunities associated with nature-based solution;<sup>4</sup> and (iii) improved roadside markets. Furthermore, complementing the various state-led initiatives, the graduation approach will be piloted to strengthen beneficiaries' wellbeing in a sustainable manner by providing livelihood assistance through agriculture, livestock, fisheries, industries, and vocational training activities.<sup>5</sup>
- 7. CRBIFRERMP will be implemented within four priority subprojects, namely Dibrugarh, Palasbari-Gumi/Guwahati West, Morigaon and Goalpara (Appendix 1). The main project benefits comprise: (i) reduced riverbank erosion; (ii) mitigation of flood damage; (iii) increased agricultural production; (iv) land reclamation and development; and (v) improved access to ferry ghats.
- Similarly to the recently completed ADB-financed AIFRERMIP (2010-2020), the Flood and River Erosion Management Agency of Assam (FREMAA) will be the executing agency of the proposed project. FREMAA is the Client for these nonconsulting services.

## B. Objectives of the Services

9. The main objective of the services is to provide the information and data required to evaluate the economic benefits of the proposed project interventions under CRBIFRERMP which will be implemented within four priority subprojects, namely Dibrugarh, Palasbari-Gumi/Guwahati West, Morigaon and Goalpara. The main project benefits comprise: (i) reduced riverbank erosion; (ii)

water level, and (iii) sufficient freeboard for potential climate change related increases in flood discharges.

FREMAA will share data as appropriate with stakeholders such as Assam Inland Water Transport Development Society (to support construction of ferry-crossing ghats and navigation) and the Brahmaputra Board.

- mitigation of flood damage; (iii) increased agricultural production; (iv) land reclamation and development; and (v) improved access to ferry ghats.
- 10. The Service Provider will gather information from: (i) certified data in the Detailed Project Reports (DPRs) to be provided by FREMAA at the start of the Services, and (ii) data to be collected during a field survey within each of the four subproject areas.<sup>6</sup>
- 11. Then, FREMAA will share with ADB the study findings for ADB to undertake a detailed assessment of economic benefits of the proposed project interventions and an economic cost benefit analysis to determine the economic viability of each subproject as well as the overall project.

#### C. Scope of the Services

#### **Preparatory Tasks**

- 12. In close consultation with FREMAA and WRD staff, the Service Provider will undertake the following preparatory tasks:
  - Review the proposed project interventions with respect to: (i) riverbank protection,
     (ii) flood embankment strengthening, (iii) land reclamation via channel closure; and
     (iv) ancillary intake structures;
  - Acquire an understanding of the nature and scale of the likely economic benefits associated with each project intervention;
  - Collect and compile all relevant certified DPR data;
  - Prepare questionnaires and checklists for use in the field survey;
  - Select a group of representative villages to be included in the field survey within each subproject area; and
  - Contact local leaders within each of the selected villages and develop a schedule for the Service Provider to visit the villages during the field survey.

## Field Survey and Data Analysis

- 13. The Service Provider will conduct the field survey which will cover a minimum of 40 villages (i.e.: approximately 10 villages within each of the four subproject areas). In each subproject area, the field survey will include both protected and unprotected villages<sup>7</sup>. It should, however, be noted that there could be significantly more interventions in some subprojects, so the number of villages included in the field survey for each subproject should be adjusted accordingly with a higher number of villages selected in subprojects with major riverbank protection works. In addition, to collect data on the present and future value of charland to be reclaimed through the proposed project interventions, at least two villages located in the areas adjacent to each charland area will also be included field survey.
- 14. To collect relevant information/data, the Service Provider will use rapid rural appraisal techniques (e.g. focus group discussions (FGDs) and participatory mapping8). FGDs will be held with selected villagers representing a wide range of local households. Village leaders will assist with the selection of villagers and, for each village, about 15 to 20 household heads should be selected to participate in the FGDs. Selected villagers will be drawn from households which have been vulnerable to damages and losses due to riverbank erosion and flooding in recent years and should also include

representatives from below poverty line (BPL) households as well as women headed households.

15. The Service Provider will collect, analyze and assemble, as a minimum, the following information and data (to be then used separately by ADB to assess the economic benefits of proposed interventions):

#### Riverbank Protection

- Area of land (in hectares), as well as number of houses and buildings, lost to riverbank erosion in recent years within each subproject area. The location and extent of the areas vulnerable to riverbank erosion (over the next five years) along river reaches to be protected under the proposed project by revetment works within each of the four subprojects. Maps of the areas vulnerable to riverbank erosion should also be provided;
- Current land use, i.e. areas (in hectares) of agricultural and grazing land, forests, settlements, and commercial/industrial land in the locations vulnerable to riverbank erosion within each of the four subprojects as well as in areas protected by riverbank protection works, based on an analysis of recent satellite imagery (e.g. Google Earth). This analysis should be undertaken over a 3 to 5 year period to identify significant trends in land use, e.g. expansion of commercial/industrial land, during this period. These trends would also be confirmed during the field survey;
- Prices of agricultural, settlement and commercial land, as well as the annual rental values for agricultural land, houses and shops, in areas vulnerable to riverbank erosion within each of the four subprojects; and
- Prices of agricultural, settlement, and commercial/industrial land, as well as the annual rental values for agricultural land, house and shops, in adjacent areas protected from riverbank erosion. For protected areas in Palasbari-Gumi and Dibrugarh subprojects under the recently completed ADB-financed AIFRERMIP Tranche 1 project and Tranche 2 project, refer to AIFRERMIP Benefit Monitoring and Evaluation, End Term Evaluation Final Report<sup>9</sup>).

#### Mitigation of Flood Damage

- Extent of flooded areas (in hectares) due to flood embankment breaches and overtopping in locations vulnerable to flooding within each of the four subproject areas;
- Month and year of the flood events during which the embankment breaches and overtopping occurred and these areas were flooded;
- Types and areas of land affected by flooding (e.g. agricultural, settlement, and commercial/industrial land);
- Value of flood damages, with respect to crops, houses, public buildings and infrastructure, for each flood event;
- · Value of other flood losses (e.g. livestock and fisheries) for each flood event; and
- Frequency of flooding due embankment breaches and overtopping and, for each subproject, sufficient data should be collected to estimate the flood damages for at least five flood events with return periods ranging from 1 in 2 years to 1 in 50 years (or 1 in 100 years if applicable);

#### Land Reclamation and Development

The location and size of potential areas of charland to be reclaimed through project interventions will be identified and estimated by FREMAA and provided to the Service Provider at the start of the Services. To estimate the increase in the value of charland following reclamation and development, the Service Provider will conduct a field survey

in at least two villages located in the areas adjacent and/or close to each charland area and provide data on:

- Current prices, as well as rental values, in charland areas; and
- Prices of agricultural land, as well as annual rental values, in villages adjacent and/or close to the charlands that the proposed project anticipates will be reclaimed from the river.

#### Increased Crop Production

To estimate the increase in the value of crop production that will be induced by improved riverbank erosion and flood mitigation measures that the proposed project will construct, the Service Provider will conduct field surveys in both protected and unprotected villages within each subproject area and will provide data on:

 Cropping patterns, cropping intensity, crop yields and crop prices in: (i) areas vulnerable to riverbank erosion and flooding, and (ii) adjacent areas protected from riverbank erosion and flooding (e.g. areas protected under the recently completed ADB-financed AIFRERMIP Tranche 1 project and Tranche 2 project).

#### Improved Access to Ferry Ghats

The estimated reduction in dredging costs at one ferry crossing ghat in Goalpara subproject area resulting from riverbank and channel stabilization, together with improved access to the ferry ghat, will be determined by the Service Provider in close consultation with Assam Inland Water Transport Development Society (AIWTDS) staff.

#### D. Minimum Required Qualifications and Experience and Staff Inputs

- 16. Qualifications of the Service Provider. The Service Provider needs to demonstrate that it has successfully carried out at least 2 socio-economic surveys of same nature and complexity as this Scope of Work in Assam or Northeast region of India during the last 5 years (starting from the day this Request for Quotation is received).
- 17. Six person-months are estimated to be required to undertake these Services. Details of inputs are provided in Table 1.

#### E. Implementation Arrangements

- 19. FREMAA will administer the contract and supervise the Service Provider's outputs. The Service Provider will be based in Guwahati with field work being conducted within the four priority subprojects areas. Over the whole duration of the Services, the Service Provider will work closely on a daily basis with Deputy Chief Executive Officer (Dy. CEO) of FREMAA, FREMAA staff as well as with the implementation and partner agencies involved in the preparation of the proposed project. The Senior Economist/Team leader of the Service Provider will report to the CEO of FREMAA.
- 20. **Completion schedule.** The Services are expected to start on the 2<sup>nd</sup> week of 2023 and will be implemented over a 4 month period.
- 21. The Service Provider is expected to implement a methodology and workplan that will enable all expected tasks of this Scope of Services to be accomplished within the completion schedule.
- 22. Subcontracting any part of this Scope of Work to a third party is not allowed.

### F. Outputs (Deliverables)

- 23. **Deliverables.** The Service Provider will submit to FREMAA the following reports:
  - Inception Report (0.5 month after contract signing date) which will include survey
    questionnaires/checklists, list of at least 40 villages selected for inclusion in the field
    survey, the survey schedule, and overall workplan;
  - Draft Final Report (3 months after the contract signing date); and
  - Final Report (3.5 months after the contract signing date) incorporating all comments received from FREMAA and ADB.

The Draft Final and Final Reports will comprise: (i) study objectives, (ii) survey method and approach, (iii) tabulated survey results, (iv) main study findings with respect to the economic benefits of project interventions, and (v) summary and conclusions.

- 24. In addition, the Service Provider will provide survey questionnaires/checklists, data analysis tables (including Excel spreadsheets) and any other relevant information related to the Services.
- 25. Also, the Service Provider will provide FREMAA with fortnightly, short (2 pages maximum) progress reports of the Services, including (i) work completed in the previous 2 weeks, (ii) work planned in the next 2 weeks, (iii) potential issues and recommendations, and (iv) any other relevant information related to the Services.
- 26. The report and other results should be submitted to FREMAA in hard copy as well as electronic form (\*.docx, \*.xlsx, \*.pptx, and \*.pdf or other formats accepted by FREMAA). The Service Provider will be accountable to FREMAA for all the tasks and deliverables stated above. All reports will be prepared in English and will cover all the tasks of this Scope of Services.



## Appendix B

**General Description.** The Service Provider will provide the information and data required to evaluate the economic benefits of the proposed project interventions under CRBIFRERMP which will be implemented within four priority subprojects. The Service Provider will gather information from (i) certified data in the Detailed Project Reports (DPRs) to be provided by FREMAA at the start of the Services, and (ii) data to be collected during a field survey within each of the four subproject areas



#### Appendix C

**Specific Standards.** The Service Provider will conduct the field survey which will cover a minimum of 40 villages distributed across the four subproject areas. The villages will be selected in close consultation with FREMAA and will include unprotected villages vulnerable to riverbank erosion and flooding as well as protected villages with riverbank revetment works and flood embankments. During the field survey, focus group discussions (FGDs) will be held with about 15 to 20 selected villagers representing a wide range of local households including below the poverty line (BPL) households and women headed households.

For each subproject area, the Service Provider will collect, analyze, and assemble, as a minimum, the following data:

- Area of land (in hectares) vulnerable to riverbank erosion over the next five years along river reaches to be protected by revetment works;
- Land use in areas vulnerable to riverbank erosion as well as in adjacent areas protected by revetment works;
- Prices of agricultural, settlement and commercial land (and annual rental values for agricultural land, houses and shops) in areas vulnerable to riverbank erosion as well as in adjacent areas protected by revetment works;
- Extent of flooded areas (in hectares) due to flood embankment breaches and overtopping in locations vulnerable to flooding as well as the types and areas of land affected by flooding (e.g. agricultural, settlement, and commercial/industrial land);
- Frequency of flooding (due to embankment breaches and overtopping) as well as the month and year of the flood events;
- Value of flood damages, with respect to crops, houses, public buildings, infrastructure and livestock/fisheries for each flood event. Sufficient data should be collected to estimate the flood damages for at least five flood events with return periods ranging from 1 in 2 years to 1 in 50 years (or 1 in 100 years if applicable);
- Prices (and rental values) of charland to be reclaimed as well as prices of agricultural land (and annual rental values) in villages adjacent to the charland, in order to estimate the potential increase in the value of charland;
- Cropping patterns, cropping intensity, crop yields and crop prices in: (i) areas vulnerable to riverbank erosion and flooding, and (ii) adjacent areas protected from riverbank erosion and flooding, in order to estimate the increase in the value of crop production;
- Estimated reduction in dredging costs at one ferry crossing ghat in Goalpara in close consultation with Assam Inland Water Transport Development Society (AIWTDS) staff.

## Appendix-D

**Performance Parameters.** The Services are expected to start on 7<sup>th</sup> January 2023 and will be implemented over a 4-month period. The Service Provider is expected to complete all tasks specified in the Scope of Services within this period. The study outputs (deliverables) will comprise:

- Inception Report (0.5 month after contract signing date) which will include survey questionnaires/checklists, list of 40 villages selected for inclusion in the field survey, survey schedule, and a study work plan;
- Draft Final Report (3 months after the contract signing date); and
- Final Report (3.5 months after the contract signing date) incorporating all comments received from FREMAA and ADB.
