Documentary Evidence in the form of Letter of Acceptance /Work Order/ Payment receipt/ Agreement has to be submitted.

(Similar Nature means: Changing of Media and treatment of Iron Removal Plant (Iron+Turbidity) for minimum 8,000LPH Plant)

- (b) Should have valid GST Registration.
- (c) Should have a valid Trade License of Assam.

Supporting documents to be provided for 1 (a) to 1 (c).

2. The lowest quoted (including tax) bidder at **Annexure B** fulfilling the above criterions at Sl. No. 1 will be eligible for award of contract.
3. Suppliers/Firms/Agencies are requested to visit the office to inspect the filter and tanks before submitting the quotations.
4. Any defect or other faults which may appear within the Defect Liability Period i.e. 6 (six) months, after the completion of works, arising in the opinion of FREMAA from materials or workmanship not in accordance with specification, shall upon the directions in writing of FREMAA, and within such reasonable time as shall be specified therein, be amended and made good by the Bidder, at his own cost.
