

ANNEXURE A

TERMS & CONDITIONS

1. Eligibility Criteria:

- (a) Should have carried out similar nature of work of in any Govt Department /Govt Agencies /Govt. Institutions of Assam & India/ Private Agencies /PSU /Companies /Apartments / Commercial buildings with atleast one similar work of value of minimum Rs. 70,000.00 or two works of minimum Rs. 53,000.00 each.

Documentary Evidence in the form of Letter of Acceptance /Work Order/ Payment receipt/ Agreement has to be submitted.

(Similar Nature means: Installation and repairing works of both sensor based and manually operated urinal flushing systems and installation/replacement of tiles)

- (b) Should have valid GST Registration.
(c) Should have a valid Trade License of Assam.

Supporting documents to be provided for 1 (a) to 1 (c).

2. The lowest quoted (**including tax**) bidder at **Annexure B3** fulfilling the above criterions at Sl. No. 1 will be eligible for award of contract.
3. **Suppliers/Firms/Agencies may visit the building to inspect the urinal systems before submitting the quotations.**
4. All CPVC fittings to be installed shall confirm to IS 15778:2007 and other materials should be of reputed brand (Jaquar, M-Seal, Astral, Supreme etc.) as per instructions of Engineer-in-charge, wherever necessary.
5. Defect Liability Period: 1 (One) year from the date of completion of job.
6. All the pages of the Quotation have to be signed by the authorized representative of the bidder.
