TERMS & CONDITIONS

1. Eligibility Criteria:

(a)(a) Should have carried out similar nature of work in any Govt Department /Govt Agencies /Govt. Institutions of Assam & India/ Private Agencies /PSU /Companies /Apartments / Commercial buildings with atleast one similar work of value of minimum Rs. 25,000.00 or two works of minimum Rs16,000.00 each.

Documentary Evidence in the form of Letter of Acceptance /Work Order/ Payment receipt/ Agreement has to be submitted.

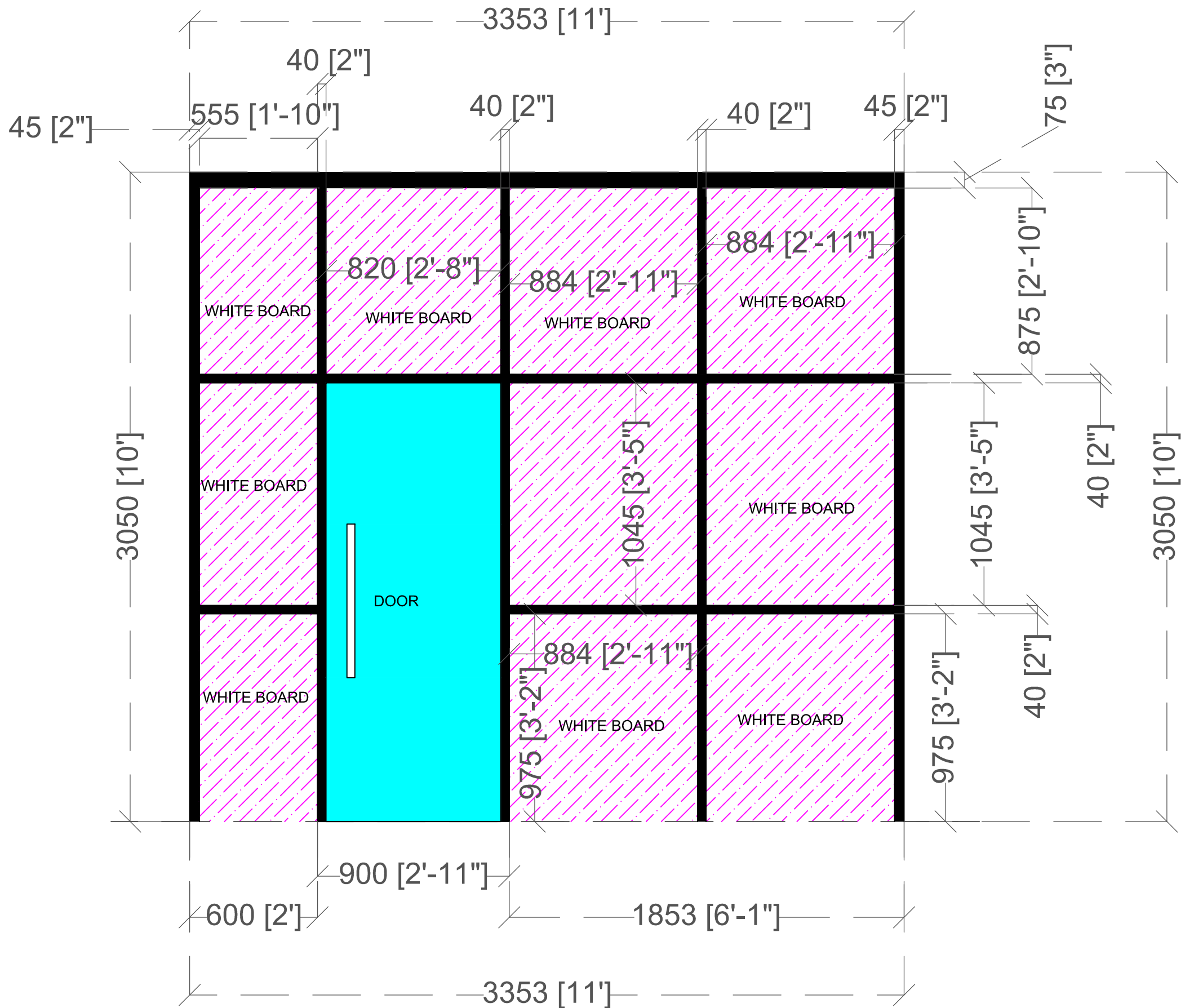
(Similar Nature means: Framing and installation of Aluminium Partition Walls and doors)

(b) Should have valid GST Registration.

(c) Should have a valid Trade License of Assam.

Supporting documents to be provided for 1 (a) to 1 (c).

2. The lowest quoted (**excluding tax**) bidder at **Annexure B2** fulfilling the above criterions at Sl. No. 1 will be eligible for award of contract.
3. Defect Liability Period: 6 (six) months from the date of completion of job.
4. Aluminium frame works shall have extruded built up sections conforming to IS: 733 and IS: 1285 with powder coated aluminium (min. Thickness of 50 micron), fixing with dash fasteners of required diameter and size, including necessary filling up the gaps at junctions with required EPDM rubber/neoprene gasket etc.
5. Aluminium sections shall be smooth, rust free, straight, mitred and jointed mechanically wherever required including cleat angle.
6. Pre-laminated particle board flat pressed shall be 12mm thick with decorative lamination on both sides conforming to IS: 12823 Grade I Type II.
