#### **TERMS & CONDITIONS**

### 1. Eligibility Criteria:

a) Should have carried out similar nature of work of in any Govt. Department /Govt. Agencies /Govt. Institutions of Assam & India/ Private Agencies /PSU /Companies /Apartments / Commercial buildings with atleast one similar work of value of minimum Rs. 6,50,000.00 or two works of minimum Rs. 5,00,000.00 each.

# Documentary Evidence in the form of Letter of Acceptance /Work Order/ Payment receipt/ Agreement has to be submitted.

(Similar Nature means: Supplying, Installation and Commissioning of Deep Tube Well by Rotary rig for a depth of atleast 100 meters)

- b) The bidder's annual average financial turnover in civil works should be at least INR **2.5 Lakhs** during the last three years (2020-21, 2021-22, 2022-23) duly audited & certified by CA. Turnover certificate for the last 3 financial years should be submitted.
- c) Should have a valid GST Registration.
- d) Should have a valid Trade License of Assam.

# Supporting documents to be provided for 1 (a) to 1 (d) failing which bid may be rejected.

- 2. The lowest quoted (**including tax**) bidder at **Annexure B3** fulfilling the above criterion at SI. No. 1 will be eligible for award of contract. However, FREMAA reserves the right to check for arithmetical errors in the Price Schedule.
- 3. The Bidder is advised to visit and examine the site conditions, nature of work, accessibility, area for storage of materials, etc. and obtain for itself on its own expense all information that may be necessary for preparing the bid. Nonfamiliarity with the site conditions will not be considered a reason either for extra claims or for not carrying out the work in strict conformity with the specifications & requirements. For site visit and any clarification/ information/ assistance, the intending Bidder may contact Chief Technical Officer, FREMAA at 4<sup>th</sup> Floor, Assam Water Centre, Basistha, Guwahati 29. A Site Visit Certificate has to be obtained and attached along with the Bid document duly signed by Chief Technical Officer, FREMAA as attached in **Annexure A2**.
- 4. All materials, labours, equipment's, T&P and heavy vehicle etc. required in the work shall have to be arranged by the bidder/contractor from his own sources in the event of allotment of the said work to him/them. Moreover, The department is also not bound to supply water or power that may be required in the execution of the work.
- 5. The bidder should clearly understand that all materials to be utilized in the work must confirm to the specifications. CIPET Certificate shall be submitted for all plastic pipe materials i.e. uPVC Pipes, Ribbed Screen Pipe, Casing Pipe and CPVC Pipes. Permissible brand of plastic pipes shall be Supreme, Ashirwad, Prince or equivalent.
- 6. Defect Liability Period: 1 (One) year from the date of completion of job.
- 7. All the pages of the Quotation have to be signed by the authorized representative of the bidder.
- 8. FREMAA does not bind itself to accept the lowest bidder and reserves the right to reject any or all the Quotations without assigning any reason.
- 9. All the above mentioned Terms & Conditions shall be binding after issue of Work Order to the successful Bidder.
