1. Eligibility Criteria:

(a) Should have carried out similar nature of work of in any Govt Department /Govt Agencies /Govt. Institutions of Assam & India/ Private Agencies /PSU /Companies /Apartments / Commercial buildings with atleast one similar work of value of minimum Rs. 26,000.00 or two works of minimum Rs. 17,000.00 each.

Documentary Evidence in the form of Letter of Acceptance /Work Order/ Payment receipt/ Agreement has to be submitted.

(Similar Nature means: Rodent Control Services including disinfection and extermination)

- (b) Should have valid GST Registration.
- (c) Should have a valid Trade License of Assam.
- (d) Should have a valid and relevant Pest Control License issued by competent authority.

Supporting documents to be provided for 1 (a) to 1 (d).

- 2. The lowest quoted (excluding tax) bidder at **Annexure B2** fulfilling the above criterions at SI. No. 1 will be eligible for award of contract.
- 3. Suppliers/Firms/Agencies are requested to visit the office to inspect the premises before submitting the quotations.
- 4. The Rodent Treatment process should include disinfection and extermination of the entire 4th Floor area of 10,550 sqft (FREMAA office) of Assam Water Centre.
- 5. Non outdated chemicals should be used and all formulation / pesticides to be used for rodent control treatment shall follow ISI specifications and should be safe for human beings and shall not have any detrimental effect on office equipment/furniture.
- 6. Suppliers/Firms/Agencies should ensure that no damages are caused to the office structure, both interior and exterior including electrical wiring and all assets during application of chemicals or installation of traps. In the event any damage occurs, it will be the responsibility of the selected bidder to rectify any damages to their original condition.
